Booking Conditions & Risk Waiver Agreement

The name on your booking form must be the same as passport. Airlines charge \$100.00 to the client for a name change after the booking has been ticketed if the name is incorrect.

Passport & Entry Visa: Your passport must have a minimum of 6 months validity. A PNG entry visa can be purchased as you go through Pt Moresby Customs. Fee = \$100.00PGK (Approx \$50.00 AUD)
If you don't have an Australian passport you will need to apply for a visa before you leave Australia.

Health Requirements: There are no mandatory vaccinations; however a course of anti-malarial tablets is recommended and available by prescription. Childhood inoculations such as tetanus should be current and a Typhoid/Hep A shot is recommended. *Please consult your doctor for further advice.*

Acceptance on the trip: All trip participants must have a written medical clearance signed by a medical doctor. The right is reserved to accept, or decline any person as a trip participant at any time eg; their right to participate will be declined if they are under the influence of drugs or alcohol or any other physical/psychological condition which may compromise their safety. We reserve the right to ask trip participants to provide us with a medical certificate. We reserve the right to insist trip participants trek with a personal porter if we consider they are risking their health or compromising the trip operation. Porter hire is \$650AUD if pre-booked. 20% is added to this cost if we have to hire a personal porter after departure date.

Baggage: Allowance is limited to 20 kilos per person plus a daypack or flight bag. While every care is taken with baggage, no responsibility can be accepted for any loss, damage or delay. Baggage insurance is recommended. We recommend that you try to limit your backpack to 14kgs and daypack to 6kgs.

Travel Insurance: We recommend that you organise travel insurance through our Travel Manager: Andrea Turner, please email andreat@travelmanagers.com.au or phone Andrea on 0414596945.
You are at liberty to organise your own travel insurance but please ensure that there is adequate inclusions for trekking, including medical emergency evacuation. Premium is approx \$100.00

Final Payments: are due 60 days prior to travel. A late payment fee of \$100.00 will apply for payments made after this date. Payments can be made by cheque or by electronic bank transfer. You will be sent a tax invoice 30 days before payment is due, which will include payment details.

Trip Price Policy

Prices are subject to change and availability. Changes may be due to international currency fluctuations, inflation, fuel prices, conditions, fees, taxes or other changes. If this occurs we will contact you.

Once your full payment has cleared into our account, we would normally not vary the price. If the trip price were to vary considerably (>10%) after you had paid your non-refundable deposit and you decided to cancel we would likely allow a full refund or transfer to another trip.

For items included in package, see the 'Kokoda Price & Inclusions' Handout (available on FSA website)

Trip price does not include: excess baggage charges, cost of passports, visa fees, laundry charges, meals not specified as being included, drinks, insurance premiums, telephone charges or any other personal expenses incurred by participant, including cost of evacuation if not covered by travel insurance.

Itinerary: Flights & trek itinerary are subject to variation depending on circumstances in PNG.

By signing below I understand that variations may be necessary for reasons including but not limited to; safety, interruptions to transportation, political unrest, prevailing weather conditions and the needs of the group.

We will advise you of any changes to flight numbers or times.

Cancellations: Deposits are non-refundable unless there are extenuating circumstances. For cancellations received less than 60 days prior to departure, cancellation fee will be 50% of the package price, plus an administration fee and any additional charges made by operators. If you cancel within 30 days of trip departure the cancellation fee is 100%. We may also choose to offer you another trip (transferable) at our discretion.

Free Spirit Adventures (FSA) reserves the right to vary or cancel a trip or a specific departure and will endeavour to advise you of cancellations not less than 56 days before departure. In the event of FSA cancelling a trip, we would work with all the members of the trip to try to provide alternative arrangements.

If you do not accept alternative arrangements we will refund all payments you have made to FSA, less any unrecoverable costs or admin fees. FSA will not be liable for any additional costs incurred by you.

No refunds will be made if a participant decides to pull out of the trek. However, non-completion of the trek due to medical emergency should be covered by travel insurance.

We advise you to have a travel insurance policy that covers cancellation or inability to travel due to illness or extenuating circumstances.

Risk Awareness / Liability Waiver

I have been advised by Free Spirit Adventures (FSA) and Getaway Trekking PNG (GTPNG) of the following matters in relation to my upcoming Kokoda trip with FSA/GTPNG:

I have been advised that travel and trekking are inherently dangerous activities. I may be killed, injured, incapacitated and experience pain, illness and suffering. I may experience loss, damage or theft of my property. Any of the above may not be FSA or GTPNG's fault or the fault of anyone. These incidents may be caused by others in my party, employees or directors of FSA or GTPNG, their subcontractors or even my guide, may be caused by environmental factors, or even just physical or mental exhaustion which can happen at any time on my trip. There is no way of predicting all the hazards I may face. While FSA and GTPNG will take reasonable precautions to minimise the risks, there is no way FSA and GTPNG can guarantee my safety on this trip 100%.

I acknowledge that the areas we will be travelling in PNG are often remote with little or no immediate medical support. In some remote areas self-rescue is the only option. My guide may need to begin first aid appropriate to the remoteness of the area and the nature of my ailment. By signing this document I certify that I have read and understood these risks and they are acceptable to me.

I also agree not to seek compensation, financial or otherwise from any incident that might occur during or associated with the trip, from FSA or GTPNG, its directors, officers, employees or subcontractors.

FSA, GTPNG and their agents including employees, guides, leaders, subcontractors and porters shall not be liable for loss, death or injury, to any of its clients or loss or damage or delay to their baggage, personal effects or other property arising from the following:

1. Acts of God including but not limited to Landslides, Ice Cliff Collapse, Avalanche, Earthquakes, Flooding and Fire;
2. Civil disturbances of any nature including but not limited to War, Revolution, Riots, Strikes or Labour Shortages;
3. Environmental Factors such as changes to trails rivers and valleys, loose rocks, unstable ground, bad weather;
4. Any other circumstance beyond our control and responsibility.
